SHOULDER CLOSURE AT EAST SOUTH AVENUE IN FRESNO COUNTY

Issued: June 6, 2019

Fresno County, CALIF. – The California High-Speed Rail Authority (Authority), in cooperation with design-build contractor Dragados-Flatiron Joint Venture (DFJV), announces an intermittent shoulder closure at East South Avenue, west of South Maple Avenue in Fresno County for utility relocation. Work is scheduled to begin Wednesday, June 12 and continue through Friday, June 28, 2019.

This work is part of Construction Package 2-3 (CP 2-3), the 65-mile stretch of high-speed rail between East American Avenue in Fresno County and one-mile north of the Tulare-Kern County line.



Shoulder closure at East South Avenue, west of South Maple Avenue in Fresno County for utility relocation. Work is scheduled to begin Wednesday, June 12 and continue through Friday, June 28, 2019.

Closure will be intermittent Monday through Friday, between 7:00 a.m. and 5:00 p.m.



Signage and flaggers will be present to direct traffic.

This schedule is subject to change. For up-to-date information please visit BuildHSR.com or the Caltrans Quickmap. Traffic laws will be fully enforced and commuters are expected to be aware of the surrounding activities, remain alert and watch for construction vehicles and personnel. The public is asked to drive carefully and be extra cautious while traveling through the construction areas.
